

RELEASE OF LIABILITY AND ASSUMPTION OF RISK

Risk acknowledgement

I acknowledge having been informed about the risks inherent to the practice of competitive climbing of type "deep-water soloing" or "Psicobloc".

I understand that the following elements describe some, and not all, of the risks associated with the activities of the Psicobloc Open Series and my participation in the competition:

- Physical injuries or death due to falls and contact with water;
- Physical injuries death caused by a bad fall or movement (concussion, scratch, sprain, fracture, etc.);
- Slipping, tripping, falling or collapsing painfully while using the installations, facilities, equipment, climbing walls, material, training areas;
- Wrongful or unauthorized use of event or site property;
- Unexpected falls due to an incorrect position, mishandling, or an unsuspected loss of control;
- Fatigue, shivers and drowsiness that can reduce reaction time and increase the risk of accident;
- Scratches or physical injuries caused by material or structures;
- Presence, actions or falls of other participants;
- Loss or breakage of personal equipment;

I understand that this is not an extensive description and that other unknown risks could cause injury, sickness or death.

I agree to play an active role in risk management by having a preventive attitude towards myself and towards others around me.

I acknowledge that I have been aware of the risks involved in participating in the Psicobloc Open Series activities and I am able to participate in the competition, knowing the facts and accepting the risks inherent to this activity.

I agree that climbing during competition involves "higher" risks to recreational practice and that "deep-water soloing" has higher risks.

Health and physical condition

I hereby state that I am in good physical condition and that I have no personal health problem preventing me from participating in the activities offered at the Psicobloc Open Series. I agree to disclose any and all physical or mental condition that could have an impact on my safety or the safety of others.

Risk agreement

I accept all risk of physical injury, accidents, sickness or death, including but not limited to sprains, tears, fractures, eye problems, cuts, scratches, contusions, dehydration, lack of oxygen, vertigo, head, neck or spinal trauma, lung problems, nervous breakdown, paralysis and-or death.

I hereby state that my participation in the competition and the activities of the Psicobloc Open Series is voluntary and that I have the right to cancel my participation at any time (at my expense).

I hereby state that I know how to swim and I am able to jump from a 55 foot height into shallow water.

Rules and regulation agreement

I agree to respect the safety rules in force within the Venue and the instructions given by the staff and volunteers of the Psicobloc Open Series and venue staff and security. I also agree to have a preventative and safe attitude towards myself and towards other individuals around me.

The organizers of the Psicobloc Open Series reserve the right to exclude anyone who demonstrates a dangerous attitude to their safety or the safety of others.

I agree to bring no alcohol or illegal drugs or use any of these on site during my attendance.

I agree not to consume any alcoholic beverages offered at the event as long as I take part in the competition during the day and I climb on the wall.

Photography and marketing

I hereby authorize the organizers of the Psicobloc open Series, namely Canadian Free Climbing Championship Inc., to use the visually photographed

portrait or image for specific use and publication in printed or electronic documents, books, pamphlets, corporate documents, promotional tools, journals, newsletters, Web sites and other documents of the same nature, from year to year, within a professional framework.

I recognize the right to Canadian Free Climbing championship Inc. to proceed, without any compensation, to the use and publication in the documents explained in the preceding paragraph. I undertake to save Canadian Free Climbing Championship Inc., from any claim that may result from the use and/or publication by anyone, including third parties, of the visual image.
